Singers in our choir are all volunteers and residents of our community. Founded in 1999, the mission of Spiritful Voices Community Choir, Inc., is to improve lives by sharing choral music. We're an independent, not-for-profit performing arts charity, not affiliated with any church, religious, educational, or political organization.

In addition to public performances at places like the Oklahoma City Festival of the Arts, the Paseo Arts Festival, the National Cowboy & Western Heritage Museum, the Crystal Bridge Tropical Conservatory at the Myriad Gardens, Penn Square Mall, and similar prestigious venues, our community choir has entertained thousands of residents at dozens of retirement centers and senior homes in central Oklahoma including Concordia Life Care Community, Epworth Villa Retirement Community, The Fountains at Canterbury, The Mansion at Waterford, Saint Ann's Retirement Center, Spanish Cove Retirement Village, Southern Plaza Retirement Center, Superbia Retirement Village, and The Wellington.

Private and corporate sponsorships provide needed funds to Spiritful Voices Community Choir, Inc., for staging and presenting free, live concerts in a variety of venues throughout central Oklahoma.

### Even modest contributions achieve significant exposure!

Unlike most other performing arts groups,

you don't need to donate tens of thousands of dollars to Spiritful Voices to achieve substantial sponsor benefits or "favored status" — and you won't be competing with huge corporations that do! While major sponsorship levels for Spiritful Voices actually start at only \$500 per season, you or your company will even receive notable recognition with a contribution of just \$200, \$100, or \$50.

### Your sponsorship directly impacts your local community!

Spiritful Voices Community Choir was founded in 1999 as an Oklahoma-based performing arts organization. Still today, our charity draws on public support from the community we serve. That means your sponsorship dollars remain in Oklahoma to serve you, your family, your friends, your neighbors, and your employees.

### Our extremely low budget maximizes your sponsorship!

Annual budgets of \$500,000, \$1 million, and \$2 million or more are "the norm" for local performing arts organizations. However, because Spiritful Voices Community Choir, Inc., relies heavily on the use of scores of volunteers each year to stage and produce our choral concerts, our annual budget is actually a fraction of those of comparable charities. Simply put, we need far less to do far more.

### why give to any charitable organization?

ynics would have us believe that corporations and individuals give to charitable organizations—like Spiritful Voices Community Choir, Inc.—only to save on taxes each year or, perhaps, to "show off" to others.

While tax breaks are a justifiable incentive for philanthropy, those who have studied charitable giving conclude that legitimate reasons besides saving taxes actually take precedence. Consider these other motives for you or your company to give:

<u>Commitment to a particular cause</u>. Not surprisingly, this is the most important reason cited in study after study. Many Americans support religion, education, the arts, civic organizations, and other good works simply because we want to serve a cause greater than ourselves. An outstanding example is Albert Schweitzer, who gave up a promising theological, medical and musical career in Europe to become a medical missionary in the jungles of Africa.

Desire to share. To the extent we have been successful, we like to give something back and let others share in our good fortune. In so doing, we deservedly gain recognition and a kind of immortality that can be achieved in no other way. Andrew Carnegie, the Scottish-born steel mogul, believed that "the man who dies rich, dies disgraced." He said, "Surplus wealth is a sacred trust which its possessor is bound to administer in his lifetime for the good of the community."

<u>Personal satisfaction</u>. Many people give for the pure enjoyment of helping others,

which is magnified by the heartwarming gratitude expressed by those who have benefited. Henry David Thoreau wrote, "Philanthropy is almost the only virtue which is sufficiently appreciated by mankind." There is no doubt that people who care for others have discovered the key that unlocks the door to true happiness.

These are the primary reasons for giving, but don't overlook the financial benefits of a donation to Spiritful Voices Community Choir, Inc.!

Once you have reached a decision to support a particular cause or organization like ours, it is only natural that you should consider the monetary benefits of your gift. Here are the many ways you or your company can benefit while helping others:

### what does your sponsorship provide?

ecause Spiritful Voices Community Choir, Inc., relies heavily on volunteers and many generous, in-kind donations to fulfill its mission, expenditures for the organization are surprisingly low. In fact, our annual budget is actually a small fraction of those of similar performing arts groups. The general operating costs associated with our charity involve these six budgetary areas:

<u>Rehearsal Expenses</u>. Each new season, volunteers collectively spend hundreds of hours over the course of a 15-week period to properly prepare for our concert tour. These essential rehearsals require a suitable facility, practice CDs, and a wide range of other resources to ensure that all volunteer singers and musicians receive the training and practice time necessary in order to present top-notch performances in the community we serve.

**Performance Equipment**. To stage and present a Spiritful Voices concert requires a considerable assortment of musical instruments, professional stage apparatus, and sound reinforcement gear. Our annual budget includes costs for new and replacement equipment, as well as expenses for maintaining existing equipment.



Transportation.

To satisfy all of the logistical requirements involved in moving our concert from venue to venue,

Spiritful Voices owns and operates its own 14' Isuzu NPR box truck. Of course, this six-ton commercial vehicle requires fuel, insurance, preventative maintenance, repairs, and a secure parking location.

Music Library. Spiritful Voices Community Choir maintains a substantial collection of \_ printed choral and instrumental music, which comprises the group's complete repertoire since the founding of the organization in 1999.



Dozens of shelves in a climate-controlled storage environment are used to house this exclusive library, representing an investment of tens of thousands of dollars. Each season, Spiritful Voices supplements this collection with additional acquisitions specific to a particular season and to keep our programming fresh, unique. challenging, and diverse for our audiences and our singers.

<u>Publicity and Promotion</u>. These invaluable expenses provide for on-going efforts to recruit new singers, attract audiences to our concerts, engage new performance venues, encourage individual donations and corporate sponsorships, maintain an Internet presence, sustain press relations, and provide general marketing and name recognition throughout our community.

Administrative Tasks. Like any organization, on-going general operational expenses are required to maintain Spiritful Voices Community Choir, Inc. These necessary monthly disbursements include telephone, postage, professional fees, photocopying, insurance, development, and office supplies and expenses.

### demographics of our audience

esearch indicates that between 2010 and 2030, the senior population (age 60 and over) will grow by 81%, while the remaining adult market (18-59 years of age) will grow by only 7%. If the 55-59 age group is also combined into the senior market, it will add 16.5 to 20.5 million more consumers during that same period, pushing the growth disparity even further.

About half of all performances presented by Spiritful Voices Community Choir during our spring and fall seasons are to seniors residing in retirement communities, independent assisted living centers, and skilled care facilities. By partnering with Spiritful Voices, you can help provide a valuable public service while aligning your corporation, product, or service with the lucrative senior market in a conscientious, caring way that isn't available anywhere else.

Marketing to seniors makes good business sense because seniors control 70% of the disposable income in the United States—that means that onethird of the nation controls two-thirds of the spending capital!

The demographic of our primary audience will almost certainly sustain significant growth in the near future for a variety of reasons:

• Increased life expectancy of the population as a whole

• Decreased need for acute care for seniors

• Increased relative wealth of elderly population

• Decreased role of traditional substitutes to retirement communities and assisted living centers—particularly hospitals and nursing homes—as a result of cost pressures

• Increased awareness and acceptance of retirement communities and assisted living centers as an alternative to family care

• Decreased time available to traditional care providers—principally family members—creating the need for alternatives

Our audiences need many of the same services and products that everyone else does. However, they are often more careful about who they do business with. They want to get to know and trust your company before doing business with you.

Our primary demographic—seniors—are a more varied group than any other age group. This niche covers all races, socioeconomic channels, political and religious persuasions, and of course, both genders.



# therapeutic benefits of live music

In addition to the obvious entertainment value provided, a growing number of studies and clinical experiences attest to the health benefits of live music, even in those who are resistive to other treatments.

There's no question that enjoying music makes us feel better, but many doctors are now beginning to believe that it does so much more.

Spiritful Voices Community Choir is committed to presenting dozens of free choral concerts each year to residents of retirement communities, independent assisted living centers, and skilled care facilities.

Music can actually trigger short- and longterm memory, decrease agitation, and enhance reality orientation and selfawareness in patients with Alzheimer's disease, and has also been found to improve the mobility of stroke patients and people with Parkinson's disease. Exposure to music is known to enhance visual and auditory perception, facilitate cognitive retraining in people with brain injuries, soothe aggressive or hyperactive behavior, and distract people with chronic illnesses from pain, thus facilitating the relaxation needed to boost the immune system and improve general health.

For all of us, live music can also help reduce stress and anxiety, resulting in

physiological changes, including improved respiration, lower blood pressure, improved cardiac output, reduced heart rate, and relaxed muscle tension. In short, music has been observed by health care professionals to provide tangible health benefits as well as to influence positive behavioral change.

The Chelsea and Westminster Hospital in London sponsors regular concerts for their patients and has seen impressive results.

A scientific study by this British hospital has found that patients who listen to live music need fewer drugs and recover more quickly than those who do not.

According to Dr Rosalia Staricoff, who carried out the study, there is growing scientific evidence that music aids physical changes, which can help heal the body. She said, "The physiological benefits have been measured. Music reduces blood pressure, the heart rate, and hormones related to stress."

Spiritful Voices Community Choir believes in the therapeutic benefits of live music. Such advantages are clearly observable in the expressions and demeanor of our audiences at each and every performance. These benefits apply not only to those elderly individuals who may suffer from a wide range of health issues, but equally to younger, fit men and women who simply relax and enjoy our performances.

### it's people who make our organization

cores of volunteers from throughout the metropolitan Oklahoma City area are dedicated to fulfilling the mission of Spiritful Voices Community Choir, Inc., by bringing quality, free choral music concerts to those who might not otherwise have an opportunity to attend such performances in a traditional setting. Over the years, our charitable organization has directly involved more than 300 volunteer singers and instrumental musicians from the community. A few of our participants are students, homemakers, or retirees, but most have "day jobs" including teachers, carpenters, pharmacists, professors, computer specialists, secretaries, nurses, bookkeepers, counselors, newspaper editors, and a variety of other occupations. Once each week during our performance seasons, these singers come together to rehearse simply for the love of music and a desire to give back to their community.

**Founder and Executive Director.** Sam P. Vladovich began Spiritful Voices Community Choir in 1999, and serves as the Executive Director of the not-for-profit corporation.

Since that beginning, Sam has brought his passion for music and teaching to the organization.

Our founder is a member of the American Choral Directors Association (ACDA) and the



Oklahoma Choral Directors Association (OCDA). A consummate educator, he has served on the faculties of Rose State College, Francis Tuttle Technology Center, and Oklahoma State University in Oklahoma City. Sam is also an award-winning photographer and an excellent chef, but undisputedly his favorite "job" is being dad to his daughter, Nichole, and husband to his soul mate, Carol Ann.

**Board of Directors.** Spiritful Voices Community Choir, Inc., is an Oklahoma charitable corporation, governed by our Board of Directors. The Board meets annually and at other times throughout the year when deemed necessary. The Board appoints an Executive Director who manages the daily duties of the performing arts organization. New members are invited to join the Board of Directors annually based on need. Ideal candidates for members of the Board are community leaders who believe in the mission and goals of Spiritful Voices Community Choir, and who will become strong advocates for our outreach programs.
